

TERMS AND CONDITIONS

DELTA BINGO AT HOME

Standard data rates apply to participants who choose to participate via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

Terms:

By participating in Delta Bingo at Home (the “Game”) you are signifying that you have read and agree to the following terms and conditions.

Game Sponsor:

This Game is sponsored by Mississauga Hall Charity Association (the “Sponsor(s)”).

OLG and Facebook Not Involved:

The Game is in no way sponsored, endorsed or administered by, or associated with, Ontario Lottery and Gaming Corporation (“OLG) or Facebook Inc. (“Facebook”). You understand that you are providing your information to the Sponsor and not to OLG or Facebook. OLG and Facebook are completely released of all liability by each participant in this Game.

FACEBOOK ACCOUNT ACCESS AND VALID EMAIL ADDRESS REQUIRED:

You may only use one (1) Facebook account (the “Account”) and one (1) email address to register to participate in this Game.

GAME PERIOD:

To participate in Delta Bingo at Home with the chance to win REAL CASH PRIZES, players will need to register during the Game entry period. Registering includes providing payment information and personal identifiers including but not limited to full name, date of birth, email address, phone number. The entry period opening date will be announced on Facebook and other platforms and will remain open until 3 days prior to the designated game date or until sold out. Links will be provided that will direct the interested parties to the payment platform (deltabingo.eventbrite.ca). Duration of the game itself will vary. All game details will be shared with eligible participants via email before game start and throughout game process.

ELIGIBILITY:

The Game is open to Ontario, Canada residents ONLY, who are eighteen (18) years of age or older at the time of entry, except:

- Delta employees (including full-time, part-time and student employees; persons who are directly on payroll; and employees who are on paid or unpaid leave) at any and all Delta locations, including Golden Nugget and Main Street Gaming Centre;
- Mississauga Charity Association board members and directors or officers of: (i) the Sponsor; (ii) the Alcohol and Gaming Commission of Ontario (“AGCO”);

- Any prize suppliers, advertising/promotion agencies and other entities or individuals involved in the development, production, administration or fulfillment of the Game.
- Any Sponsor, staff or other individuals who are restricted pursuant to any OLG policy.
- Any person(s) who have been banned from the premises for any reason or have self-excluded.

HOW TO ENTER:

This is a PAY TO PLAY game! To participate, you must be at least 18 years of age; an Ontario, Canada resident; have the ability to travel to your nearest Delta Bingo location, and have a valid email address and access to a Facebook account. All players must register in order to receive cards to play. Registration requires payment information and personal identifiers, including but not limited to full name and email address. A link to the payment platform will be shared by the sponsor on all appropriate channels, including social media, website and email (deltabingo.eventbrite.ca) on the specified entry period start date. Follow the link to the payment platform to register and pay. This link will be activated and shared before or on the entry period start date. Cards will be available for purchase up to 3 days prior to designated game date or until sold out, to allow sufficient time to process orders. **LIMITED CARDS AVAILABLE!**

Each strip contains 3 faces. Limit of ten (10) 'bundles' per transaction.

Enter valid payment information and required details to register. Once registered, you will receive a confirmation email with game specifics. Registered players must **PICK UP THEIR CARDS** at a Delta Bingo location of their choosing, on the date and time specified by the Sponsor. If you cannot pick up your cards on the specified pick up date, you will not be eligible to participate in the game. Every card is different and cards are distributed at random. It is the sole responsibility of the registrant to ensure all registration information is correct. All game packages are non-refundable.

Player must be available to pick up their purchased cards on the specified date and time, at the location they chose when they registered. Government issued identification will be required upon pickup to confirm age and purchase details. Cards will not be released to any person who did not register to play. If you cannot pick up your cards on the specified date and time, you will not be eligible for the game. We will not be releasing cards to friends or family members of registrants. Packages cannot be split or shared. Must bring in winning card to collect prize. Prizing cheques will be issued to the name of the person who brings the winning card to the Delta specified at checkout. Cheque will be available for pick up within 4 business days. Winner may visit the centre specified at checkout during operational hours to retrieve their prize. If the chosen centre is temporarily closed, the winner can visit during the following week's curbside pickup window, or arrange an alternate time with the Sponsor. Government issued photo ID will be required.

HOW TO PLAY:

On game day, those who have registered and picked up their cards can follow along with the Facebook Live Stream video on Delta Bingo's Facebook page. You must have access to a valid Facebook account to participate. Log-in to your Facebook account and visit Delta Bingo and Gaming's live video page

[https://www.facebook.com/deltabingoandgaming/live_videos/]. Next, locate the current live stream video on behalf of the Sponsor. This video stream will be available as early as 30 minutes before game start time on game days.

It is the sole responsibility of the registrant to locate the live stream on the specified date and time in order to play. Accurately marking cards and keeping up with the game is the sole responsibility of the participant. As with any Bingo game, the bingo caller mechanism is completely random, and numbers are called in the order that they appear. Each called ball will be shown in the video and remain on the display board. Videos will remain posted on Delta Bingo's Facebook page after the game has finished. Registered players must play along in real time to be considered. When a participant completes the required pattern, they must type BINGO and their card number into

the comment section of the live stream video, at the time of the live stream. Comments will be monitored throughout the game in order to see when a BINGO is declared and to stop the game in order to verify. Participants who declare Bingo must verify their card by typing the potential winning card number in the comment section. Once a bingo card is verified as a winner, that player will receive associated prize and the game is over. If there are multiple winners, the prize is split evenly amongst all winners.

Once a winner has been verified, there will be a minimum 1-minute grace period to allow any other potential winners to declare their bingo. After minimum 1 minute, the game will close, and no other bingos will be accepted.

Facebook Live Stream will be broadcast from Delta Bingo & Gaming, Mississauga (1650 Dundas St E, Mississauga, ON L4X 2Z3) using verified Bingo equipment and under constant video surveillance. All games are recorded and witnessed by multiple Delta Bingo associates and a Mississauga Charity Association member.

To be eligible to participate, all content and materials associated with your Entry (collectively, the “Entry Materials”) must: (i) be submitted and received in accordance with these Rules during the Game Period; (ii) include all required components and materials noted above; (iii) reflect the Theme; (iv) be in accordance with these Rules, including, but not limited to, the specific Submission Requirements; and (v) be in accordance with the applicable terms, rules, policies and guidelines of Facebook (the “Facebook Rules”) (all as determined by Sponsor in its sole and absolute discretion). ENTRY LIMIT:

There is a limit of ten (10) ‘bundles’ per transaction.

VERIFICATION:

All Entries are subject to verification at any time and for any reason. Sponsor requires adequate time to verify any and all potential winning cards. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued identification): (i) for the purposes of verifying an individual’s eligibility to participate in this Game; (ii) for the purposes of verifying the

eligibility, validity and/or legitimacy of any Entry, Entry Materials, Request or other information entered (or purportedly entered) for the purposes of this Game; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Game in accordance with the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of this Game will be the Sponsor's Official Clock(s). An Entry may be rejected if, in the sole and absolute discretion of the Sponsor: (i) the Entry

(including, but not limited to, any associated Entry Materials) is not submitted and received in accordance with these Rules during the Game Period; and/or (ii) the Entry Materials accompanying the Entry are not in compliance with these Rules (including, but not limited to, the specific Submission Requirements) and/or the applicable Facebook Rules (all as determined by Sponsor in its sole and absolute discretion).

SUBMISSION REQUIREMENTS:

BY SUBMITTING AN ENTRY, YOU AGREE THAT THE ENTRY (AND EACH INDIVIDUAL COMPONENT THEREOF – INCLUDING, WITHOUT LIMITATION, THE ENTRY MATERIALS) COMPLIES WITH ALL CONDITIONS STATED IN THESE RULES. THE RELEASED PARTIES WILL BEAR NO LIABILITY WHATSOEVER REGARDING: (I) THE USE OF YOUR ENTRY (OR ANY COMPONENT THEREOF – INCLUDING, WITHOUT LIMITATION, THE ENTRY MATERIALS); (II) PARTICIPATION IN ANY PROMOTION-RELATED ACTIVITIES; (III) ANY USE, COLLECTION, STORAGE AND DISCLOSURE OF ANY PERSONAL INFORMATION; AND/OR (IV) IF DECLARED THE WINNER, THE PRIZE

(INCLUDING ANY USE OR MISUSE OF THE PRIZE). THE RELEASED PARTIES SHALL BE HELD HARMLESS BY YOU IN THE EVENT IT IS DISCOVERED THAT YOU HAVE DEPARTED FROM OR NOT OTHERWISE FULLY COMPLIED WITH ANY OF THESE RULES AND/OR THE FACEBOOK RULES (AS APPLICABLE). THIS RELEASE AND INDEMNITY SHALL CONTINUE IN FORCE FOLLOWING THE TERMINATION OF THE GAME AND/OR AWARDING OF ANY PRIZES.

'Entry Materials' are categorized as any information submitted at the time of registration; any correspondence on Sponsor owned pages or communication channels before, during or after the game, including but limited to correspondence with other participants in the chat feature of the live steam video. The Sponsor and/or its promotional agency or designated content moderator (the “Reviewer”) reserves the right to screen all Entry Materials. Any Entry Materials that the Reviewer deems, in its sole and absolute discretion, to violate the terms and conditions set forth in these Rules are subject to disqualification. The Reviewer reserves the right, in its sole and absolute discretion at any time and for any reason, to remove any Entry Materials (or any part thereof) and/or to request an entrant to modify, edit and/or re-submit his or her Entry Materials (or any part thereof) in order to ensure that the Entry Materials comply with these Rules, or for any other reason. If such an action is necessary at any point during or after the Game, then the Sponsor reserves the right, in its sole discretion, to take whatever action it deems necessary based on the circumstances – including, without limitation, disqualifying the Entry Materials (and therefore the corresponding Entry and/or the associated entrant) – to help ensure that the Game is being conducted in accordance with the letter and spirit of these Rules. Disqualified entrants will not be considered for reimbursement or refund, where applicable, except at the Sponsor’s discretion.

PRIZE(S):

There will be one (1) cash prize awarded to each verified winner(s) of each pattern in the form of cheque. All prizes are paid out in Canadian funds. Prizing cheques will be issued and available within 7 business days at the location selected by the registrant at time of purchase. Must bring in winning card to collect prize. Sponsor will coordinate a date and time for cheque pick up with the winner(s). Government issued photo identification will be required.

Each prize has a set minimum amount (outlined above). This set amount is the minimum amount to be paid out to verified winner(s) of each pattern. This amount will increase based on the prize pool. Prize pool increases based on number of participants. In the case of multiple winners, the prize amount will be divided evenly.

Each Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Sponsor in its sole and absolute discretion). No substitutions except at Sponsor’s option. All other costs, fees and expenses associated with a Prize that are not expressly indicated above will be the sole and absolute responsibility of the confirmed winner. If an eligible winner cannot accept (or is unwilling to accept) the applicable Prize (as awarded) for any reason; and/or is determined to be in violation of these Rules (all as determined by the Sponsor in its sole and absolute discretion); then he/she will be disqualified (and will forfeit all rights to the applicable Prize).

GENERAL RULES:

This Game is subject to all applicable federal, provincial and municipal laws. The decisions of the Sponsor with respect to all aspects of this Game are final and binding on all entrants without right of appeal. The Released Parties will not be liable for: (i) any failure of any website or any platform during the Game; (ii) any technical malfunction or other problems of any nature whatsoever, including, without limitation, those relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software; (iii) the failure of any Entry, Entry materials, Request and/or other information to be received, captured or recorded for any reason whatsoever, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to an entrant's or any other person's computer or other device related to or resulting from participating in the Game; (v) anyone being incorrectly and/or mistakenly identified as a winner or eligible winner; and/or (vi) any combination of the above. If the entire stream is unsuccessful due to factors outside of Delta's control, there will be another scheduled game shortly after. The exact time of the rescheduled game will be announced on Facebook and emailed to participants. If executing a second game is not an option, game may be cancelled without notice. In this event, registrants will be issued a full refund.

The Sponsor reserves the right, in its sole and absolute discretion, to withdraw, amend or suspend this Game (or to amend these Rules) in any way, in the event of any cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Game as contemplated by these Rules, including, without limitation, any error, problem, tampering, unauthorized intervention, fraud or failure. Any attempt to undermine the legitimate operation of this Game in any way (as determined by Sponsor in its sole and absolute discretion) may be a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor reserves the right, in its sole and absolute discretion, to cancel, amend or suspend this Game, or to amend these Rules, in

any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever.

The Sponsor reserves the right, in its sole and absolute discretion, to adjust any of the dates, timeframes and/or other Game mechanics stipulated in these Rules or elsewhere, to the extent deemed necessary by the Sponsor, for purposes of verifying compliance by any participant, Entry, Request or other materials with these Rules, or as a result of any problems or failures, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Game as contemplated in these Rules, or for any other reason.

Without limiting the generality of any other section in these Rules, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

By entering this Game, each entrant expressly consents to the Sponsor, its agents and/or representatives, storing, sharing and using the personal information submitted only for the purpose of administering the Game and in accordance with Sponsor's privacy policy. This section does not limit any other consent(s) that an individual may provide the Sponsor or others in relation to the collection, use and/or disclosure of their personal information.

In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Game-related materials, the terms and conditions of these Rules shall prevail, govern and control to the fullest extent permitted by law.

These Rules are governed by the domestic laws in force in Ontario and the federal laws of Canada applicable therein. You agree to submit to the exclusive jurisdiction of the courts of the Province of Ontario and agree that those courts are a convenient forum in which to resolve any dispute arising in relation to these Rules.

The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.
